### SUPPLEMENT TO RENTAL AND LEASING RULES

Terms used but not defined in this document will have the meaning subscribed to such terms in that certain <u>Declaration of Covenants</u>, <u>Conditions</u>, and <u>Restrictions for Savannah</u>, recorded as Document No. 2003-R0176314 (Volume 5546, Page 2083) in the Official Public Records of Denton County, Texas, as the same may be amended from time to time, including the supplemental <u>Rent House Rules Amendment</u> (Article 19 of the Master Declaration), recorded as Document No. 2007-129051 in the Official Public Records of Denton County, Texas (together, the "**Master Declaration**").

The Board hereby adopts this Supplement to Rental and Leasing Rules (the "Policy") as a supplemental policy to establish equitable procedures pursuant to the Declaration.

### DISCRIMINATION BASED ON METHOD OF PAYMENT PROHIBITED

House Bill 1193, passed during the 2023 Legislative Session, provides as follows:

"A property owners' association may not include or enforce a provision in a dedicatory instrument that prohibits or restricts a property owner from renting a dwelling to a person based on the person's method of payment."

Savannah Homeowners Association, Inc. will suspend enforcement of Article 19, Section 19.5.2, which restricts the rental of owners' homes to individuals who receive publicly financed or subsidized housing, for so long as it is illegal, based on applicable law, to enforce such provision.
